Subject: **PROMOTION TO THE GRADE OF PRINCIPAL PRIVATE SECRETARY (PPS) OF AFHQ STENOGRAPHERS SERVICE FOR THE DPC YEAR 2019 (REVIEW CUM SUPPLEMENTARY)**

Reference this office Note of even number dated 29<sup>th</sup> Jun 2020 vide which Review cum Supplementary Panel for the DPC year 2019 for promotion to the grade of Principal Private Secretary (PPS) has been issued.

2. Consequent to repatriation from deputation with UIDAI, Hyderabad, Shri K Muniramkrishna, Private Secretary (PS) has reported to this office on 21 Oct 2020 (F/N). Further, the officer is empanelled for promotion to the grade of PPS for the Panel Year 2019 (Review cum Supplementary) issued by this office Note under reference.


3. Accordingly, Shri K Muniramkrishna, PS is promoted to the grade of PPS in Level -11 as per VIIth CPC (pre-revised Grade Pay Rs.6600/-) (Group 'A' Gazetted) on regular basis and posted to MS Branch against an existing vacancy. He may be taken on strength of MS Branch w.e.f. 21 Oct 2020 (F/N).

4. As per the AFHQ Stenographers' Service Rules 2004, amended vide SRO 29 dated 18<sup>th</sup> April 2012, Shri K Muniramkrishna will remain under probation for a period of two years wef the date of promotion. This period can be extended at the discretion of the Competent Authority. Two Assessment Reports duly filled, first at the completion of one year and second at the completion of second year, may be forwarded to CAO/APAR (P-2) Cell.

5. The pay of the officers shall be fixed as per existing instructions on the subject matter.

6. The promotion order will be subject to outcome of Hon'ble Supreme Court order on reservation issue in terms of DoP&T OM dated 15 Jun 2018.
